President's Perch

As I pen this, we just got out of what for the most part was a seasonally warm December with three successful club-sponsored CBCs completed and an introductory event held with Lancaster County Parks to introduce people of all ages to the wonderful world of Christmas Bird Counts. Thanks to everyone who gives their time to contribute to our counts and on a larger scale what is North America's longest-running Citizen Science Project.

The Lititz CBC held on Dec. 29 saw a recorded high temperature of 65 degrees at Lancaster Airport – my car read 66 at Middle Creek at one point! Despite the balmy temperature, most small bodies of water were still mostly iced over and the lake at Middle Creek was about 80 percent iced over. Despite all that, we're back to cold temperatures and anticipating the first plowable snow of the season during the first full week of January in 2025 – conveniently aligned with Farm Show week in Southcentral Pennsylvania. We have already had a few minor dustings that have brought out some of the specialties of the season like Horned Larks, Snow Buntings and Lapland Longspurs – birds that otherwise can go unnoticed in agricultural fields but the snow can bring to roadside and exposed areas of the landscape.

Our 2025 membership renewal process is now underway online and in the coming days hard-copy renewals along with our 2025 program brochure will be mailed out to all members. If you have already renewed online or submitted payment by mail prior to the mailing, please simply disregard the renewal form in your mailing, but please read the accompanying letter that provides an overview of 2024 accomplishments and make sure to hold onto the coveted 2025 program brochure included. In short, our membership has grown tremendously over 2024 and brought us to our highest levels since the early 2000s. Each of you are to thank for that and I'd like to personally thank you for continuing to support the club and our mission. We certainly couldn't do it without you. PROPOSED BYLAWS UPDATE

As approved at our Fall 2024 Board Meeting, one bylaws amendment was approved to bring to the membership for acceptance. The first reading of this proposed amendment will occur at the Jan. 9, 2025, club meeting. A second reading of the amendment as well as a vote to accept it will be held at the Feb. 13, 2025, club meeting.

Summary:

Amend Article 6 Section 2

Change from:

“Section 2 – Fiscal Year: The fiscal year of this Corporation will be from May 1 to April 30.”

Change to:

“Section 2 – Fiscal Year: The fiscal year of this Corporation will be from January 1 to December 31.”

Explanation of change:

The club previously approved bylaws / operating changes to change our program / membership year to coincide with the calendar year. The board feels it is imperative our fiscal year should also coincide with the calendar / membership year. The board also approved shifting our elections to being held at our December club meeting going forward so the terms of board members align with our operating year. It should be noted the election change does not require a bylaws amendment as our bylaws only specify elections must be done at an annual meeting.

LCBC NOMINATIONS & ELECTION NOTICE

The election of LCBC officers and directors will be held at the April 10, 2025, meeting at 7 p.m. at the Middle Creek Wildlife Management Area (WMA) Visitor Center. Jeff Musser has once again agreed to chair the Nominating Committee. Please contact him at jmusser1956@gmail.com or (717-471-2032) if you would like to nominate someone, including yourself, for election to the LCBC Board of Directors or as an officer. The officer position of secretary is expected to become vacant and is a priority for filling for the organization. On top of a vote on the board, the requirement to take minutes at our one board meeting a year is also a duty of the position.

Special Note: The club's bylaws do not specify a month our elections must be held other than it must be done at an annual meeting. As approved at our Fall 2024 Board Meeting, the terms for those elected in April 2025 will expire Dec. 31, 2025. We will hold elections for 2026 at the club's Dec. 11, 2025, meeting. Future years will also feature elections being held in December with terms running January 1 through December 31. This change is being made so our terms coincide with our operating / membership / fiscal year.

PREVIEW OF COMING EVENTS

Thursday, January 9, 2025, 7 p.m. until 8:30 p.m. – Monthly Club Meeting - “Avian Conservation in an Urbanized Fragmented Landscape: Evolving Techniques and Developing Partnerships” with Dan Ardia, Franklin & Marshall College

Location: North Museum of Nature and Science, 400 College Ave, Lancaster, PA 17603

Bird populations face increasing threats from rapid environmental change and human impacts on the landscape. The talk will use Lancaster as a case study for how to study and conserve birds in our fragmented and urbanized landscape. Results from existing research will be combined with describing new approaches to monitor birds in Lancaster and beyond.

Dan Ardia is a Professor of Biology at Franklin & Marshall College. He has been studying the effects of rapid environmental change on birds across the world and in Lancaster. Dan serves the ornithological community as the Board Chair of Avinet Research Supplies and a Past President of the Association of Field Ornithologists. He is also active in local conservation efforts as a member of the Board of Directors of Lancaster Conservancy and PA Master Naturalist.

REVIEW OF COMPLETED EVENTS

October 5, 2024 – Fall Migration bird walk at Middle Creek. We had a total of 16 participants join us for this walk. We started at the Middle Creek Visitor Center and walked the interior “edge” of the conservation trail. Weather was clear with a light ground fog which burned off quickly as the sun came up. We had a total of 38 species for this part of the walk. Highlights included a Peregrine Falcon, American Kestrel and the group got great looks at a very cooperative Wilson’s Warbler. There was an almost continuous movement of Blue Jays flying over as well as some foraging in the trees. Some rarities had been reported earlier in the morning at Willow Point by another birder, so the group migrated to that area to attempt to find those. We got good looks at the Long-billed Dowitcher that was foraging with some Great Egrets and Lesser Yellowlegs, but missed the other reported rarities. We had 29 species on that section. October 12, 2024 – “Big Sit” at Middle Creek. The annual "BIG SIT" at Middle Creek WMA was held for the 11th year on Saturday, October 12, 2024. A total of 77 species were identified by 17 participants who assisted throughout the day. The 77 species was the third highest total for this event only to be out done by 88 in 2022 and 83 in 2023. There were 4 new species added to the "BIG SIT" list which now stands at 138 species. The new species added included Least Sandpiper, Red-headed Woodpecker, Black-crowned Night Heron, and Chestnut-sided Warbler. Other highlights for the day included 10 species of waterfowl plus Pied-billed Grebe, 11 species of raptors which included all three falcon species, all 7 possible woodpecker species that could be seen at this time of year, American Woodcock, Winter Wren, Barn Swallow, Catbird, Common Raven, Indigo Bunting, Purple Finch and Barred Owl. October 19, 2024 – Noel Dorwart Park. John Lahr led a bird walk at Noel Dorwart Park with eight people present. It was a cold and blustery day and the birds were sheltered mostly in the underbrush. We managed to see and or hear about 11 species.

October 20, 2024 – State Game Lands 220. On a crisp late October day, our group of five birders explored the trails at this State Game Lands in Northeastern Lancaster County that is well-known for high-quality upland habitat that attracts a variety of migrating birds.

The warm-season grass plots and upland thickets held large numbers of sparrows (nine species including Swamp, Fox and Savannah), flocks of Yellow-rumped Warblers feeding on poison ivy berries, and the expected Ring-necked Pheasants at this stocked location. A male American Kestrel devouring a meadow vole was an exciting sight for all.

Classic late fall songbird migrants like Ruby-crowned and Golden-crowned Kinglets, Yellow-bellied Sapsucker, Blue-headed Vireo, Hermit Thrush, Eastern Phoebe, Palm Warbler and Purple Finch highlighted our tally of 51 species found on this enjoyable fall bird walk.

November 9, 2024 – Bird Walks at North Museum’s Fall Fest at Millport Conservancy. Club President Ted Nichols and Board Member Doug Anderson tabled on behalf of the club at the North Museum and Millport Conservancy’s annual Fall Fest held all day at the Millport property as part of our blossoming partnership with the North Museum. The event occurred on a beautiful fall day and served as a fundraiser to support both STEM (Science, Technology, Engineering and Math) education programming at the North Museum and Millport Conservancy’s efforts to restore the Lititz Run Creek through soil erosion control, wetlands restoration, and stream management. Information on birding and the club was provided to attendees as well as handouts to encourage bird journaling. Bird walks were also led through the property at 11 a.m. and 2 p.m. with nearly 30 individuals venturing out to see roughly 30 different species. Highlights included great looks during the morning walk at a drake Wood Duck, many fulfilling views of Red-bellied Sapsuckers, a close encounter with a Yellow-rumped Warbler and Winter Wren and several interacting vocalizing Red-tailed Hawks over the property throughout the day. Board member Anne Esbenshade, who runs the Live Animal Room for the North Museum, had a display of her nature photography – with many great bird pictures – featured at the event while also working the event and sharing numerous critters she brought along to showcase the museum’s Live Animal Room Residents. Museum leadership and board members made several visits to the club’s table and were appreciative of our support of the event.

December 7, 2024 – Chestnut Grove Natural Area Field Trip. Sarah Gotwols led 5 birders on a field trip to Chestnut Grove Natural Area. Thirty-nine species were observed including Common Raven, Osprey, a variety of songbirds and an excellent display from a Wilson's Snipe, circling overhead several times before descending into the wetlands right in front of the group.

December 13 – 15, 2024 – Chincoteague National Wildlife Refuge (NWR) and Eastern Shore trip. Club President Ted Nichols II led a group of 23 enthusiastic birders from the LCBC on our annual birding trip down to Chincoteague and the Eastern Shore. The club's longtime annual offering once again covered four days and three nights. The first day featured stops at Eastern Neck NWR and Blackwater NWR in Maryland. We also made a diversion for a Loggerhead Shrike that had been continuing at a site between the two refuges, but the bird was only seen once that day before we arrived. We redeemed ourselves after that stop by getting great looks of a dark form Rough-legged Hawk that we chased not far from Blackwater. The first night of the trip offered many the opportunity to witness an unannounced classified launch of an Electron rocket from Wallops Island during this trip.

The trip again offered all attendees a guided boat tour through the inner coastline of Assateague Island as well as tidal marshes and other bayside areas around Chincoteague. We revisited Mutton Hunk Fen State Natural Area Preserve where we found an Orange-crowned Warbler and added several new stops around Chincoteague to this year's trip to include one that offered great looks of Virginia Rails and Short-eared Owls.

The group finished the trip with a rough total of 113 species – many of which were new to the annual trip since Ted has been leading it as well as new to many longtime attendees of the trip! We did encounter several large flocks of Snow Geese which we don't typically encounter when the trip is held in November and we found two Ross's Geese in the flock. We were also honored to have Trevor MacLaurin, who has conducted research on American Oystercatchers at

Chincoteague for several seasons, able to join us for some of our adventures. Trevor is from Canada and luckily was in the area to give a presentation during the off season and has been one of the most active birders in the Chincoteague area the last few years finding many notable rarities. Thanks to Mike Epler for compiling eBird lists for the trip and all who participated!

December 15, 2024 - Southern Lancaster County Christmas Bird Count (CBC) by Derek Stoner, Count Compiler.

On Sunday, December 15, 2024, a team of 43 observers found 109 species of birds during a day afield that featured temperatures ranging from 24 to 37 degrees under cloudy to partly cloudy conditions. Smaller bodies of water like ponds were mostly frozen, while the reservoirs and rivers were primarily ice-free. Weather in the week preceding the count was relatively mild.

The most notable birds found are a well-photographed Trumpeter Swan on the Susquehanna River near Fishing Creek, Greater White-fronted Goose at Muddy Run Reservoir, two Sandhill Cranes at Octoraro Reservoir and Long-tailed Duck on the river below the Holtwood Dam.

Since this CBC circle features significant waterbodies that draw both large numbers and diversity of waterfowl, it's interesting to see the variation year to year in the waterfowl category. This year we tallied 20 species of waterfowl overall, with the duck "misses" being Lesser Scaup, American Wigeon, Northern Shoveler and Common Goldeneye. A flyover flock of Snow Geese was noted by multiple groups but no Ross's Goose could be found among them.

The team of thirteen feeder watchers recorded the only observations of Baltimore Oriole and Pine Warbler. These two birds were found at separate feeder locations several miles apart and both were seen feeding on peanut butter suet offerings.

With 177 cumulative species being recorded over the 48 editions of the SoLanCo Christmas Bird Count, it's interesting to note that exactly 50 species of birds have been recorded on every single count. To test your local bird knowledge, can you guess what those 50 species are?

December 22, 2024 – Christmas Bird Count for Kids (CBC4Kids). John Lahr and Lisa Sanchez led the Christmas Bird Count for Kids at Lancaster County Central Park. It was a cold and blustery day again with 16 people present including 6 kids. The youngest was 4 and he and his mother left after about a half hour. They later came back and walked along Mill Creek with us and then headed up another trail to go home. The kids were all very enthusiastic and pointed out birds even by name. We were surprised at the number of birds we saw even with the cold and wind. We had 14 species for the 2 hours we walked. Notable were a never-ending stream of American Crows that seemed to be heading in the direction of the Park City roost. A Brown Creeper, several Golden-crowned Kinglets, a Bald Eagle, two Red-tailed Hawks and a Northern Harrier were highlights. There was a distinct lack of ducks on the Mill Creek but that could have been due to the amount of ice on the creek.

December 22, 2024 – Lancaster Christmas Bird Count. This report will be available for the next newsletter.

December 29, 2024 – Lititz Christmas Bird Count. In support of the 125th Audubon Christmas Bird Count, the Lititz CBC was held on Dec. 29, 2024. The count is centered on Brickerville and was first held in 1905. The count saw the day encounter some rain early on – especially during owling – but it cleared up by the time we saw daylight and really started counting in the morning. Despite temperatures rising to 66 degrees, most small bodies of water were mostly covered with ice and the main lake was about 80 percent covered with ice. A pizza lunch was again offered to all count participants at Middle Creek midday and allowed for a break and some camaraderie. Nearly 45 individuals participated this year. Data is still coming in and has not yet been compiled as it is not due to Audubon until February 28. A further update on the count will be provided at a later time. Highlights at this point include four Sandhill Cranes and a Ross's Goose that were continuing at Middle Creek. Thanks to everyone who participated in 2024 and continues to support the Lititz CBC. Many thanks also to the Pennsylvania Game Commission and their staff at Middle Creek and continuing to provide us with amazing access to the wildlife management area. It should also be noted that many of these staff members

participate in the count all day helping to maximize our coverage and counting efforts. The next Lititz CBC – to support the 126th Audubon CBC -- is scheduled for Dec. 28, 2025.
